P. C. : 1. Perused Petition. Heard Ld. Advocate for the Petitioner. This Petition is for Probate of Last Will and Testament and Codicil of the deceased filed by the Petitioner Jasmine Iqbal Singh being the sole Executrix named under the Will of the deceased. Deceased Ranjeet Kaur also Ranjeet Kaur Panesar said to have died at Mumbai on 02.08.2016. Copy of Death Certificate is annexed to the Petition. Copy of Aadhaar Card of the deceased as ID Proof is annexed to the petition.

2. Ms. Rayate, Advocate for the Petitioner submits that deceased left behind him last Will and Testament and Codicil which was duly executed at Mumbai on 11.05.2006 and 12.09.2013 respectively. The said Will and Codicil is in English language.

3. Ms. Rayate, Advocate for the Petitioner submits that deceased was governed under the Hindu Succession Act, 1956. It is submitted that the husband of the deceased predeceased the deceased. Exh. E. to the Petition is a copy of his death certificate. Exh. F. to the Petition is copy of death certificate of the deceased son of the deceased who expired on 23.12.2023. Save

) Petitioner submits that it took considerable
) time and effort to search the Will, which
) was not found. As such to compile the
) details of estate it took considerable time. It
) was only now the Petitioner was able to
) compile the details of the estate. Hence the
) delay if any in filing this Petition deserves to
) be condoned. Thus, the delay is explained.

) Affidavits of two daughters, one grandson

) mentioned in para 9 are on record. Affidavit
) of Deepak Chandanani and Khushru Patel
