2. Perused Schedule. The Petitioner is seeking permission to publish the Citation in two newspapers viz. "Free Press Journal" in English Language and in "Navshakti" in vernacular language i.e. Marathi.

3. Perused the Affidavit dated 19th February 2024 annexed to Chamber Order. In Para- 4 of the said Affidavit, it is stated that the citation sent through the Sheriff of Mumbai to 1) Smt. Sulochana Mahendra Jadhav, Nee Sulochana Ganu Jadhav, 2) Smt. Nanda Dhondiram Kamble nee Nanda Ganu Jadhav daughters of the deceased, was returned by the postal authorities with the remark "left". In Para 6, it is stated that the Petitioner had tried to search and locate the daughters of the

) Petitioner has requested to publish the
) citation in newspapers.

) 4. In Para 6, of the Affidavit the
) petitioner has sought permission to serve
) citation upon aforesaid legal heir of the
) deceased by way of substitute service by
) publication of citation in local newspapers
) one in “Free Press Journal” in English
) Language and in “Navshakti” in vernacular
) language i.e. Marathi and Affidavit of
) service 4th April 2023 is also filed by the
) Petitioner.

) 5. Perused the Petition. It is mentioned
) and confirmed that the averment made in
) the Affidavit in respect of the next of kin of
) the deceased, whose addresses or not
) known to the Petitioner.
