The Petitioner had carried out the diligent search but she could not find her whereabouts. It is further stated that she did not contact the parents thereafter. The petitioner had also made efforts to trace the said daughter of the deceased by visiting social media sites such as facebook, massengers, instragram but her whereabouts could not be found. She has therefore requested to permit her to publish the Citation in the newspapers “Free Press Journal” in English Language and in “Hindwasi” in Sindhi language.

4. Perused Para-9 of the Petition, it is mentioned and confirmed that the averment made in the Affidavit in respect of the addresses not known to the Petitioner.

5. Heard. The Ld. Adv. for the Petitioner submits that the whereabouts of the nephew of the deceased is not known to the Petitioner despite diligent search. He further submits that the Chamber Order be allowed and the Petitioner be permitted to publish the Citation in “Free Press Journal” in English Language and in “Hindwasi” in Sindhi language.
