2. Perused Schedule. The Petitioner is seeking permission to publish the Citation in two newspapers viz. "Free Press Journal" in English Language and in "Navshakti" in vernacular language i.e. Marathi.

3. Perused the Affidavit dated 19th July, 2024 annexed to Chamber Order. In the said Affidavit, it is stated that Maya Balraj Sawant (Widow of the deceased) and Tejashri Balraj Sawant (Married daughter of the deceased), have severed the relations with the family for last 21 years and they are not in touch with any of the family members since then. It is further stated that they have not made any attempt to meet the family members and to get in touch with the family members. The Applicant has further stated that she has made attempts to find the said legal heirs of the deceased but could not get any information.
