4. Perused the Petition. In Para-9 of the Petition, it is mentioned and confirmed that the averment made in the Affidavit in respect of the addresses not known to the Petitioner.

5. Heard. The Ld. Advocate for the Applicant submit that the (1) Shalini Ravindra Vitta, (2) Laxmi Ravindra Vitta, (3) Saraswati Ravindra Vitta and (4) Kavita Vijay Sherla, legal heirs of the deceased could not be served with citation and their whereabouts are not known to the Applicant. He further submits that the Applicant is not aware of the whereabouts of the said legal heirs of the deceased. He therefore prays that the Chamber Order be allowed. For the reasons stated in Affidavit dated 20th June, 2024 annexed to the Chamber order and averment made in Para-9 of the Petition, the present Chamber order is granted, and the same is signed separately.

6. Publication of Citation to be done in two newspapers viz. (1) “Free Press Journal” in English and (2) “Navbharat Times” in Hindi language, within four weeks from the date of uploading the order. Office is directed to issue fresh Citation, if required.

7. Applicant to file Affidavit annexing therewith the newspapers within two weeks once, the publication is done.
