) Husband of the Deceased whereabouts of any Class-
) II heirs of the husband of the deceased as he had
) predeceased the deceased and more than 26 years
) have elapsed since death of deceased. He further
) submits that the name of newspaper to publish the
) Citation in vernacular language is incorrectly
) written in the Affidavit in Support as “Navshakti”
) instead of “Navbharat” but in the Schedule to the
) Chamber Order is written correctly. He, therefore,
) prays that the Chamber Order be allowed. For the
) reasons stated in Affidavit dated 26th August, 2024
) annexed to the Chamber order, the present Chamber
) order is granted, and the same is signed separately.
