4. Perused Para-5 of the Petition. It is mentioned and confirmed that the averment made in the Affidavit in respect of the addresses not known to the Petitioner.

5. Heard. The Ld. Advocate for the Applicants submit that the Pannalal Shrinath Yadav, Husband of the Deceased could not be served with citation and her whereabouts are not known to the Applicants. He further submits that the Applicants are not aware of the whereabouts of the said Pannalal Shrinath Yadav. He therefore prays that the Chamber Order be allowed. For the reasons stated in Affidavit dated 5th September, 2024 annexed to the Chamber order and averment made in Para-5 of the Petition, the present Chamber order is granted, and the same is signed separately.

6. Publication of Citation to be done in two newspapers viz. (1) "Free Press Journal" in English and (2) "Navbharat" in Hindi language, within four weeks from the date of uploading the order. Office is directed to issue fresh Citation, if required.
