5. Heard. The Ld. Advocate for the Applicant submits that the Petitioner is not aware of the whereabouts of the wife and children of the deceased or any other Class-I or Class-II legal heirs of the deceased and the Petitioner had made diligent search of the legal heirs of the deceased at the last known address at Kolhapur but he could not trace anyone from there. He further submits that the Applicant had made enquiry with the neighbours of the said deceased but no one could give the information about whereabouts of any legal heirs of the said deceased. He therefore prays that the Chamber Order be allowed. For the reasons stated in Affidavit dated 8th October, 2024 annexed to the Chamber order and averment made in Para-10 of the Petition, the present Chamber order is granted, and the same is signed separately.
