4. Perused Para-8 of the Petition, it is mentioned and confirmed that the averment made in the Affidavit in respect of the addresses not known to the Petitioner.

5. Heard. The Ld. Advocate for the Applicant submits that the deceased had a son viz. Mr. Avtarsingh Jogindersingh Saini, from the first wife viz. Mrs. Niranjana Kaur, who expired on or about 18th December, 1993 and the whereabouts of the said Mr. Avtarsingh Jogindersingh Saini is not known to the Applicant / Petitioner and the deceased during his lifetime never mentioned about his said son from his first wife. He further submits that the Applicant / Petitioner had tried to locate the address and whereabouts of the said Mr. Avtarsingh Jogindersingh Saini but he could not find out. He therefore prays that the Chamber Order be allowed.
