) 2. Perused Schedule. The Petitioners are
) seeking permission to publish the Citation in
) two newspapers viz. "Free Press Journal" in
) English Language and in "Navshakti" in
) vernacular language i.e. Marathi.
)

) 3. Perused the Affidavit dated 20th
) September, 2024 annexed to Chamber Order. In
) the said Affidavit, it is stated that the name of
) all known legal heirs of the deceased have been
) mentioned in Para-4 of the Petition but the
) heirs of the deceased severed their ties with each
) other many years ago and the Petitioners are
) not aware of their marital status and do not
) know about their heirs. It is further stated that
) the Petitioners had made efforts to find out the
) same but despite due and diligence, the
) Petitioners could not get any information.
) Petitioners therefore prayed for publication of
) Citation by way of substituted service upon all
) concerned legal heirs of the deceased.

) 4. Perused Para-4 of the Petition. It is
) mentioned and confirmed that the averment
)

) made in the Affidavit in respect of the addresses
) not known to the Petitioners.

) 5. Heard. The Ld. Advocate for the
) Applicant submits that the name of all known
) legal heirs of the deceased have been mentioned
) in Para-4 of the Petition but the heirs of the
) deceased severed their ties with each other
) many years ago and the Petitioners are not
) aware of their marital status and do not know
) about their heirs. She further submits that the
) Petitioners had made efforts to find out the
) same but despite due and diligence, the
) Petitioners could not get any information. She
) therefore prays that the Chamber Order be
) allowed.

) 6. For the reasons stated in Affidavit dated
) 20th September, 2024 annexed to the Chamber
) order and averment made in Para-4 of the
) Petition, the present Chamber order is granted,
) and the same is signed separately. Publication
) of Citation to be done in two newspapers viz.
) (1) “Free Press Journal” in English and (2)
) “Navshakti” in Marathi language, within four
) weeks from the date of uploading the order.
) Office is directed to issue fresh Citation, if
) required.
