This Application has been filed under the provisions of Section 11 of the Arbitration and Conciliation Act, 1996 (the Act) for appointment of an Arbitrator to arbitrate upon the disputes and differences arising between the parties under the Loan Agreements dated 5 November 2019 and 17 July 2020.

2. In this Application, by an order dated 2 December 2024 passed by this Court, the Court recorded that it proposed to nominate Ms. Mahek Bookwala, a practising Advocate of this Court as the sole Arbitrator and requested the Arbitrator to file a disclosure by 9 December 2024.
