We have learned Counsel for the parties on this Interim Application which is filed praying for condonation of delay in filing the aforesaid Appeal under Section 260A of the Income Tax Act. The delay which is sought to be condoned is of 72 days.

2 Learned Counsel for the Applicant has placed on record Affidavit of Service. However, the Respondent is not represented.

3 Having perused the memo of Application and considering the period of delay, in our opinion, the reasons as set out certainly provide for an appropriate justification and a sufficient cause shown by the Applicant with regard to the delay in filing the Appeal. The position in law as laid down in catena of judgments with regard to the principles to be followed on condoning the delay, is well settled. Hence, it is in the interests of justice that the delay is condoned.
