1. We have heard learned counsel for the parties on this interim application which is filed praying for condonation of delay in filing the aforesaid appeal under Section 260A of the Income Tax Act. The delay which is sought to be condoned is of 62 days.

2. The position in law in catena of judgments in regard to the principles to be followed on condoning the delay, is well settled.
