ORAL ORDER

1. Learned counsel for the petitioner has filed a memo dated 11.01.2022 seeking for withdrawal of the above petition, which reads as under:

"The petitioner herein respectfully submits:

1. *It is submitted that the petitioner has filed above writ petition against the impugned action of the respondent wherein the respondent-railways-IRCTC have deviated from the Railway Code, Cabinet decision Catering Policy, General Finance Rule etc while calling tender, auction, empanelment etc to award Catering Licenses over Indian Railways.*
2. *However that the Respondents has assured that upcoming Catering contracts will be intern of the Railway Code, Cabinet decision Catering Policy, General Finance Rule etc.*
3. *In view of that it is warranted to withdraw the above case and file afresh with new facts and question of Law if needed.*
