THIS WRIT PETITION (CIVIL) HAVING COME UP FOR ADMISSION ON
24.01.2024, THE COURT ON THE SAME DAY DELIVERED THE FOLLOWING:

JUDGMENT

Amidst the various assertions, averments and allegations in this writ petition, when this matter was called today, the learned counsel for the petitioner, confined his plea that the 2nd respondent - Senior Divisional Commercial Manager be directed to take up Ext.P6 representation - wherein, he has requested for refund of certain amounts under a licence, which was awarded earlier, on account of the fact that during certain portions of time covered by it, he was unable to operate it due to reasons which were beyond his control - and dispose it of, within a time frame to be fixed by this Court.

2. Smt.S.Krishna- learned Central Government Counsel appearing for the respondents, submitted that there is no legal impediment in Ext.P6 being taken up and disposed of by the 2nd respondent; but prayed that this Court may not make any affirmative declarations on the entitlement of the petitioner to any relief and leave it to be decided by the competent Authority, in terms of law.

In the afore circumstances, I allow this writ petition and direct the 2nd respondent to take up Ext.P6 representation of the petitioner and dispose of the same, after affording him and any other person who may be interested an opportunity of being heard; thus culminating in an appropriate order and necessary action thereon, as expeditiously as is possible, but not later than two months from the date of receipt of a copy

of this judgment.

Until such time as the afore is done and the resultant order communicated to the petitioner, all further recovery action against the petitioner pursuant to Ext.P1 will stand deferred.
