ORDER

Since the limited prayer sought for in this writ petition is for disposal of the representations, this Writ Petition is disposed of, by directing the 10th respondent to consider the representations of the petitioner dated 09.01.2023 and 06.10.2023, respectively, on its own merits and pass appropriate orders in accordance with law, after giving due opportunity of hearing to the petitioner as well as the rival claimants/interested parties, if any, within a period of two months from the date of receipt of a copy of this order. There shall be no order as to costs.
