property by laying the boundary stones.

2. Heard the learned counsel appearing for the petitioner and the learned Special Government Pleader appearing for the official respondents.

3. Having regard to the submissions made by the learned counsel on either side and taking into consideration the limited prayer sought for by the petitioner, without expressing any opinion with regard to the merits of the case, this Court directs the respondents to consider the petitioner's representation dated 27.12.2023, if the petitioner is otherwise eligible, after issuing notice and giving opportunity of hearing to the petitioner, any other legal heirs of the deceased Jaganathan, adjacent land owners of four boundaries of the subject property and interested parties/rival claimants/objectors if any, as the case may be and pass appropriate orders on merits and in accordance with law. The said exercise shall be completed within a period of three months from the date of receipt of a copy of this order.
