2. The learned Additional Public Prosecutor on instructions submitted that the case of the petitioner's mother C.Chinnammal is under consideration.

3. In view of the above submissions, we direct the respondents to consider the representation of the petitioner, dated 25.10.2023 for premature release of his mother and pass appropriate orders on merits and in accordance with law, within a period of eight weeks from the date of receipt of a copy of this order, and communicate the same to the petitioner.

4. With the above direction, this writ petition is disposed of. No costs.
