Prayer : Writ Petition filed under Article 226 of the Constitution of India praying for the issuance of a Writ of Mandamus directing respondents herein to take immediate steps to assess all the facts in the petitioner's wife Saradha's case, who is undergoing her sentence more than 18 years in Special Prison for Women at Vellore and consider her case for premature release as per the G.O.Ms.No.64, Home (Prison-IV) Department, dated on 01.02.2018 either by the above mentioned government order or by placing her case for consideration by constituting Advisory Board for recommendation of her release on humanitarian grounds, within the time stipulated by this Court.
