**ORDER**

2. The parties have decided to compromise the dispute amicably among themselves.

This Court also enquired both the parties and was satisfied that the parties have come to an amicable settlement between themselves and the same is recorded.

Accordingly, in view of the settlement arrived between the parties this Civil Revision Petition stands allowed by setting aside the order passed by the 1st respondent dated 30.12.2021 and the joint compromise memo shall form part and parcel of this order. No costs. Consequently, connected miscellaneous petitions are closed.
