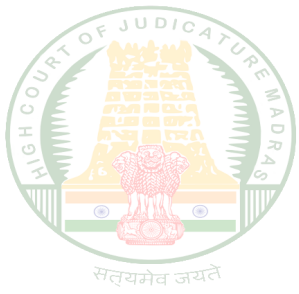

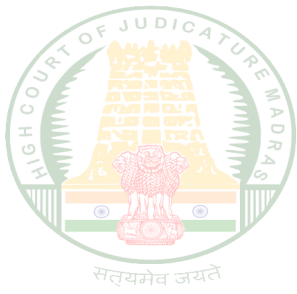

COMMON JUDGMENT

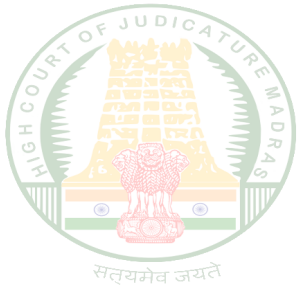
