ORDER

The petitioner seeks bail in Crime No.1984 of 2023 registered
under Sections 3(2) (a), 4(2) (c) 5(1)(d) of Immoral Traffic (Prevention) Act,
1956 on the file of the respondent police.

2.The petitioner/A1 had been remanded to judicial custody on 12.12.2023. It is the case of the prosecution that A1 is the manager and A2 is the owner of the Spa “Luxux Wellness SPA” at Sky Park Complex, Katharpatti, Royapuram Road, Tiruppur.. It is stated that the defacto complainant found one lady there and thereafter he had given the complaint.

3. The learned Government Advocate stated that the investigation has proceeded and four witnesses had been examined

4.Taking all the factors into consideration and considering the period of incarceration, this Court is inclined to grant bail to the petitioner subject to the following conditions.

5.Accordingly, the petitioner is ordered to be released on bail on condition to execute a bond for a sum of **Rs.10,000/- (Rupees Ten Thousand only)** with two sureties each for a like sum to the satisfaction of the **learned Judicial Magistrate No.1, Tiruppur**, and on further conditions that:

[a] the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity.

[b] the petitioner shall report before the respondent Police, daily at 10.00 a.m., until further orders.

[c]the petitioner shall not abscond either during investigation or trial.

[d] the petitioner shall not tamper with evidence or witness either during investigation or trial.

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560].

[f] If the accused thereafter absconds, a fresh FIR can be registered under Section 229A IPC.
