COMMON JUDGMENT

The appeals are against the suit for partition. The parties have filed a compromise memorandum, in and by which, they have agreed to divide the properties among themselves. The mode of division has also been explained and the plans have been filed to show the properties allotted to each one of the sharers. The fixed deposits available with the two banks, who figured as respondents 4 and 5 in the Appeals, have also been agreed to be divided between the parties. The Memorandum of Compromise has been signed by the parties as well as their respective counsel. The parties who are virtually present affirm the compromise.
