J U D G M E N T

This First Appeal has been filed to set aside the Judgment and Decree made in O.S.No.20 of 2011 dated 30.06.2023 on the file of learned District Judge-II, Kancheepuram.

2. Both parties are present in Court. The learned Counsel for the Appellant as well as first Respondent files Joint Memo of Compromise whereby the amount of Rs.3,65,000/- has been paid by the Appellant to the first Respondent on 21.12.2024 as follows:

(a) Rs.3,50,000/-(Rupees Three Lakhs Fifty Thousand Only) via Demand Draft in D.D.No.909701, Ref. No.000042510329 dated 20.12.2024 drawn at HDFC Bank, ITC Centre Annasalai, Chennai – 600 002 in favour of S.Rajendran (the 1st Respondent herein).

(b) Rs.15,000/- (Rupees Fifteen Thousand Only) in cash paid by the Appellant to the first Respondent on 21.12.2024.
