It is the case of the petitioner that she has purchase the property from the second respondent by virtue of sale deed dated 28.02.2022, however, later she got to know that the property stands in the name of third respondent. Hence, she preferred a complaint before the first respondent in Application No.714/2023/A4, which is pending. Hence, this writ petition.
