PRAYER: Writ petition filed under Article 226 of the Constitution of India, praying to issue a writ of Certiorarified Mandamus calling for the records relating to the impugned order of the 1st respondent in G.O.Ms.No.363 Finance (PGC) Department dated 23.08.2013 and quash the same in so far as it denies the benefit of conversion of dearness allowance as dearness pay on

retirement for those who retired on or after 01.01.1996 and direct the respondents to convert the dearness allowance as dearness pay with effect from 01.03.2000 and calculate the revised pension and grant him all consequential benefits.

ORDER

The instant writ petition has been filed to quash the G.O.Ms.No.363 Finance (PGC) Department dated 23.08.2013.

2. On perusal of the typed-set, it appears that the petitioner has already sent representation dated 06.03.2015 to the respondents, however, no order has been passed. The learned counsel for the petitioner having filed the writ petition to quash the G.O.Ms.No.363, at this length of time, instead of going into the merits, now prays for a restricted relief of direction to the respondents to consider the representation. Therefore, this Court is of the view that it is appropriate to direct the respondents to consider the
