4.A report had been received that he had complied with the condition to appear before the Inspector of Police, R.S.Puram Police Station, Coimbatore.

5.The learned counsel for the petitioner stated that the petitioner would continue again to appear before the said R.S.Puram Police Station.

6.But that may not be proper since FIR in Crime No.220 of 2023 had been registered by the Inspector of Police, Nungambakkam Police Station, which is the Investigating Agency.
