Prayer: Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Declaration, declaring that the Petitioners who are working as Guest Lecturers for more than 5 to 15 years and who have acquired M.Phil Degree Prior to July 11, 2009 are exempted from the requirement of NET/ SLET/SET/PH.D for recruitment and appointment as Assistant Professors or any equivalent position in any Universities colleges and Institutions as per G.O (Ms) No.5, Higher Education (H1) Department dated 11.01.2021 and the University Grants Commission notifications dated 04.05.2016 and 18.07.2018 and consequently direct the 1st and 2nd Respondents to appoint the Petitioners as Assistant Professor or any equivalent position in any Universities, Colleges or Institutions.
