This petition has been filed seeking modification of the condition imposed by the court below while allowing the application in Crl.M.P.No.53133 of 2023, filed by the petitioner for return of vehicle. The Court below while allowing the application under Section 451 Cr.P.C., seeking for return of vehicle, by order dated 22.11.2023, had imposed certain conditions and one such condition was that the petitioner shall execute a bond for a sum of Rs.10,00,000/- with two sureties each for a like sum.

2. The learned counsel for the petitioner submitted that the petitioner was not able to mobilize funds and hence, seeks for modification of the condition.

3. Taking into consideration the facts and circumstances of the case, the condition No.(i) shall stand modified as follows:

“The petitioner is directed to execute a bond for a sum of Rs.10,000/- with two sureties each for a like sum”.
