2. It is seen that the interim order granted by this Court on 14.05.2015 continues till now. However, as per the amendment in the Tamil Nadu Urban Local Bodies (Permission for Erection of Digital

3. With the above direction, this writ petition stands allowed. Consequently, connected miscellaneous petition is closed. There shall be no order as to costs.
