PRAYER : Writ Petition filed under Article 226 of the Constitution of India, praying to issue a Writ of Mandamus, to direct the respondents to restore the old basic pay and grade pay sanctioned to the petitioner which was refixed at the time of awarding him the first review benefits with effect from 01.02.2014 to the same level alongwith consequential pay including grade pay and restrain them in recovering the monthly installment from the pay of the petitioner and refund the amount already deducted from the petitioner in this regard immediately.

ORDER
