Learned Additional Public Prosecutor further submitted that if fresh representation is made by the petitioner, the same will be enquired and a decision will be taken with regard to providing police protection.

4. Considering the submissions made by learned Additional Public Prosecutor, there shall be a direction to the petitioner to give a fresh representation to the first respondent. The first respondent, on receipt of the same, shall conduct an enquiry by issuing notice to all the interested parties and shall take a decision within a period of four (4) weeks.
