3. When the matter was taken up for hearing, learned Additional Public Prosecutor submitted that the representation given by the petitioner has been rejected by the second respondent through proceedings dated 27.01.2024.

4. In the light of the above development, the relief as sought for in this writ petition cannot be granted. It is left open to the petitioner to challenge the order of the second respondent in the manner known to law.
