ORDER

This Writ Petition has been filed seeking a writ of mandamus to direct the first respondent to consider and pass orders on merits by disposing the representation made by the petitioner on 11.12.2017 within a stipulated time.

During the course of hearing, the learned Special Government Pleader appearing for the respondents 1 to 3 on instructions submits that the representation of the petitioner dated 11.12.2017 was already considered and passed an order on 20.11.2019 itself.
