2.The learned Additional Public Prosecutor on instructions submitted that the complaint given by the petitioner was enquired in CSR No.622 of 2023 and it was closed on 10.10.2023. The relevant material was also placed before this Court.

3.On going through the relevant material, it is seen that the rival party has undertaken that he will not create any law and order problem and that he will workout his remedy only before the competent Civil Court. In the light of this undertaking, the enquiry has been closed. The above
