4. The petitioner was appointed as Cholera Mazdoor in the office of the Panchayat Union, Koradacherry on 01.03.1992 and worked as Cholera Mazdoor till 31.12.1997. Thereafter, he filed a Writ Petition No.14302 of 2009 to direct the first respondent namely the Director of Rural
