Divisional Officer, Hosur under Section 145 of Cr.P.C., since claim was made by



two parties and there was a likelihood of breach of piece. This communication was sent to the Revenue Divisional Officer on 29.01.2024.

5.In the light of the above development, there shall be a direction to the Revenue Divisional Officer, Hosur to conduct the enquiry and to take a final decision, within a period of two weeks from the date of receipt of copy of this order.
