2. The petitioner is challenging the notice issued under Section 128 of the Tamil Nadu Urban Local Bodies Act, 1998. The impugned notice is a show cause notice soliciting reply from the petitioner.

Naturally, the reply would be considered by the respondents before passing order under Section 128 of the Act of 1998.
