The petitioner herein who is the wife of the detenu viz., Senthil, S/o.Periyasamy, confined at Central Prison, Cuddalore, has come forward with this petition challenging the detention order passed by the second respondent dated 20.01.2024 slapped on her husband, branding him as "Goonda" under the Tamil Nadu Prevention of Dangerous Activities of
