2. Heard the learned counsel appearing for the petitioner and the learned Special Government Pleader appearing for the respondents.

3. Having regard to the submissions made by the learned counsel on either side and taking into consideration the limited prayer sought for by the petitioner, without expressing any opinion with regard to the merits of the case, this Court directs the respondents to consider the petitioner's representation dated 11.07.2022, if the petitioner is otherwise eligible and conduct enquiry in the manner known to law after issuing notice to the petitioner, adjacent land owners of four boundaries of the subject property and interested parties/rival claimants/objectors if any, if already not issued and dispose the petitioner's representation on merits and in accordance with law if already not disposed of. The said exercise shall be completed within a period as stipulated in the Circular No.R1/2005632/2022 dated 17.07.2023 issued by the Commissioner of Land Administration.
