ORDER

This writ petition has been filed for direction to the respondents to consider the claim of the petitioner for her transfer permanently to Kanyakumari Medical College Hospital.

2. The petitioner is hailing from Kanyakumari District. After completion of her M.Sc., Nursing Course, she was temporarily appointed as contract nurse. Thereafter, she was brought into regular time scale of pay. She was transferred to Government Rajiv Gandhi General Hospital, Chennai and served till 02.06.2022. Thereafter, based on the petitioner's representation, she was sent on deputation to Government Kanyakumari Medical College Hospital on 03.06.2022. Since her parents are residing in the Kanyakumari District, she is taking care of them and her sister is affected by brain fever and having 90% of disability. She is also under care of the petitioner.

3. Therefore, the petitioner submitted representation for

transferring her to Kanyakumari District Government Medical College Hospital.

4. Admittedly, the petitioner is working as Staff Nurse on deputation in the Government Kanyakumari Medical College Hospital on 03.06.2022. Considering the same, the 2nd respondent is directed to consider the petitioner's representation dated 12.01.2024 and pass orders on merits in accordance with law within a period of eight weeks from the date of receipt of copy of this order.

5. With the above direction, this writ petition is disposed of. Consequently, connected miscellaneous petition is closed. No costs.
