The petitioner has made an application under Sections 6 and 7 of the Right to Information Act, 2005 before the Public Information Officer / Principal, Government Law College, Chengalpet, seeking certain information regarding admission in the Law College and its Hostel for his wife. Since no proper details have been given, the petitioner has preferred a first appeal before the First Appellate Authority / Director of Legal Studies, Purasawalkam High Road, Chennai and the same was partly allowed by directing the Public Information Officer / Principal, Government Law College, Chengalpet, to provide details regarding certain questions. However, as the petitioner requires details of all his questions, he has preferred a Second Appeal before the Respondent herein on 28.12.2023 in S.A.No.21685/F/2023 and the same is pending till date. In this regard, the petitioner made a representation before the Respondent on 23.01.2024 and the same was not considered yet. Hence, this Writ Petition.
