**ORDER**

This writ petition is filed for a direction to the respondent to depute a surveyor to inspect, survey and measure the said property and report actual measurement and boundaries of the petitioners' property in Patta No.105, Re-Survey No.202, Sub Division No.4, No.72, Moppiripalayam Village, Palladam Taluk, Tiruppur District in pursuance to the representation of the petitioners dated 07.08.2023.

2. It is the case of the petitioners that they submitted a representation on 07.08.2023 with a request to survey their property, which is pending without consideration.

3.The learned Government Advocate submitted that the petitioners have not made an online application, if the same is made, the application will be considered and orders will be passed on merits within a reasonable time as fixed by this Court.

4. Heard learned counsel for the petitioner and the learned Government Advocate appearing for the respondent and perused the materials available on record.

7. With the above direction, this writ petition is disposed of. No costs.
