ORDER

(Order of the Court was made by **M.S.RAMESH, J.**)

When the petitioner's brother had sought for grant of Ordinary Leave for the convict prisoner, we had granted leave from 24.01.2024 to 07.02.2024 through orders passed in W.P.No.1005 of 2024 dated 22.01.2024. In the present writ petition, the petitioner seeks for extension of the earlier leave granted by this Court. The reason assigned in the petition is that the convict prisoner is suffering from migraine and the doctors have advised him for treatment.

2. The learned Additional Public Prosecutor, on instructions, submitted that though the convict prisoner was admitted in the Government Hospital, Pollachi, his medical condition is stable.
