Additional Public Prosecutor on instructions submitted that based on the complaint given by the petitioner, an enquiry was conducted and it was closed on 23.01.2024 and that a direction was given to the parties to agitate the dispute before the appropriate Civil Court.

4. In the light of the above development, the relief as sought for by the petitioner cannot be granted by this Court. It will be left open to the petitioner to workout his remedy under Section 156(3) of Cr.P.C., before the competent jurisdictional Court.
