2. The 1st respondent is the wife of the deceased and respondents 2 to 7 are sons and daughters of the deceased. Here it is stated that the deceased had shares in Reliance Industries Ltd., Reliance Power, Reliance Capital and Reliance Infrastructure. The details have been given in the petition.

3. The respondents have filed their consent affidavit.
