ORDER

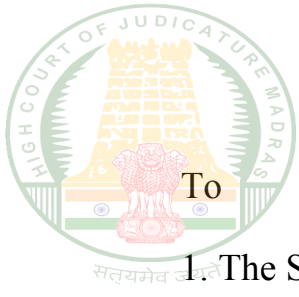
4. The learned Special District Judge has expressed genuine inconvenience and difficulties in disposing of the matters in compliance of the order of this Court.
