2. Mr.C.Selvaraj, learned Panel Advocate (TNCSC) for the respondent Nos.1 and 2 also would submit that the claim is pending and the petitioners are also working as on date.

In view thereof, this Writ Petition is disposed of with a direction to the third respondent to consider the said case in CPS Case No.E/187/2018 and dispose of the same on merits and in accordance with law within a period of three months from the date of receipt of a copy of this order. Since the petitioners are admitted to be working as on date, until the disposal of the application by the Inspector of Labour, Nandanam, Chennai, let status *quo* as on today be maintained. There shall be no order as to costs. Consequently, connected miscellaneous petitions are closed.
