3. Learned Government Advocate further submits that the authority would conduct a survey within a period of two months from today and depending upon the report of the survey, if any encroachment is found, steps in accordance with law, would be undertaken to remove the encroachments expeditiously.

W.M.P.No.6879 of 2024, filed to permit the petitioners to file a single writ petition is allowed, inasmuch as they have paid separate set of court fees.
