Pay in the revised scale in the cadre of Deputy Collector from 1.1.1996 (Rs.8000-275-1350)	- Rs.8275/-
Increment as on 1.1.1996	- Rs.275/-
Pay as on 1.1.1996 (after increment)	- Rs.8550/-
Pay as on 1.1.1997 (after increment)	- Rs.8725/-
Pay as on 1.1.1998 (after increment)	- Rs.9100/-
